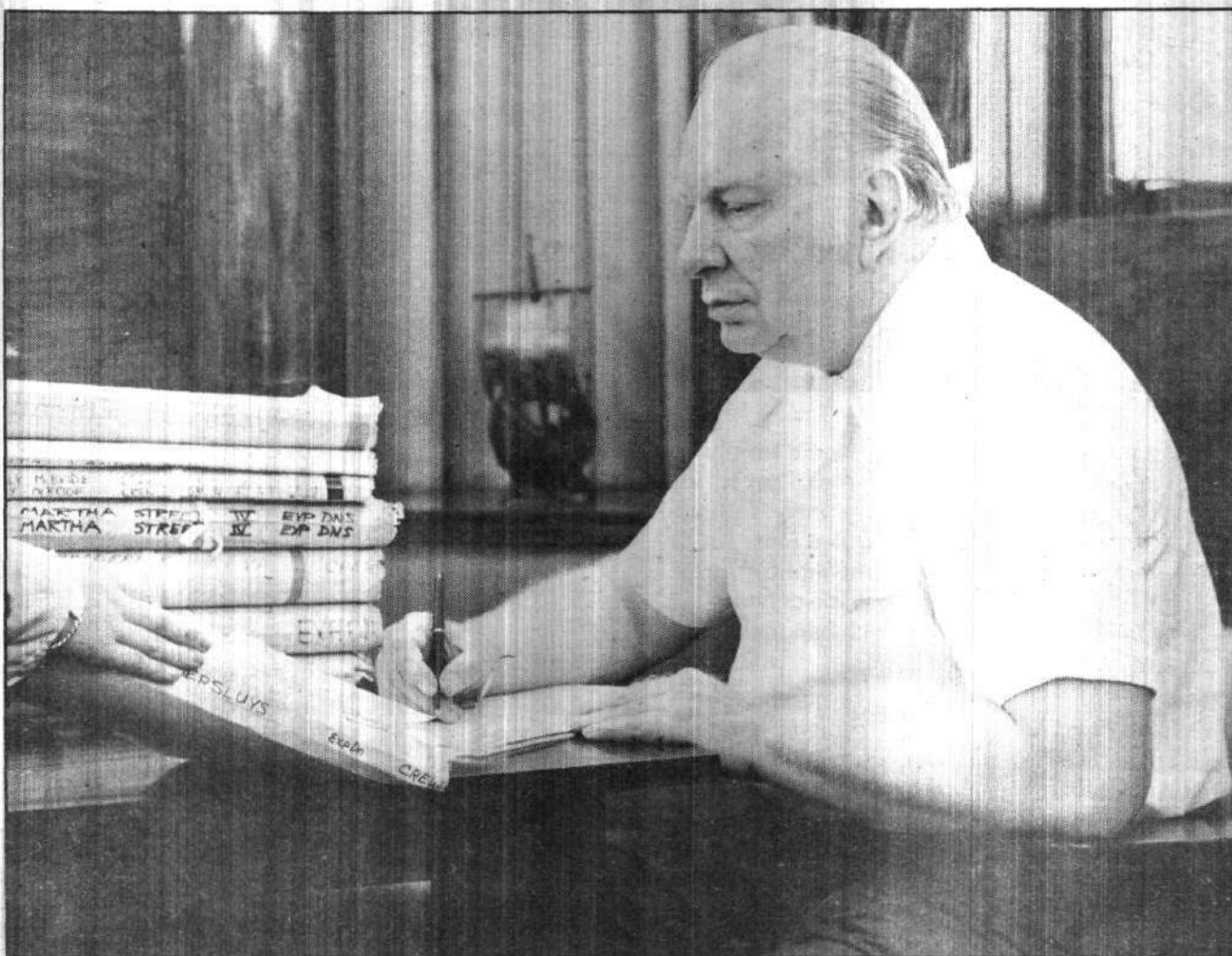

## Welcome to the INTERNSHIP

by L. Ron Hubbard

**W**

e are determined that you *will* become flawless, you will become flubless. It's not even difficult to do. All you have to do is just do it. Not wonder about doing it, just do it.

The only way you will ever become a perfect auditor is by auditing. When you get down to basics, you find out auditors audit.

We require that auditors audit *flublessly*.

You say, "Wait a minute. There's something you missed there. An auditor gets *results*." No, we don't give a darn about your results. We know what the tech will do. That's not under test.

We take the result for granted. We know what result is obtainable with what. The C/Ses are hot as pistols.

Results are not in question. Pes are not in question. These are no longer variables. You're on a very very certain narrow line. You do this and the result is that. Our whole job is to make you do the "this" that gives you the "that".

It's all very elementary, so elementary it's almost impossible to be grasped.

You will find out that there are no wobbles and no

variations. With total application, actually auditing, actually doing the C/S<sup>1</sup> the way it's supposed to be done, you will see the result.

Can you as an auditor obtain the result that is required? The result that's required is for you to audit

flublessly. Can you do it *flawlessly*, *flublessly*, by the book?

You will always get the result if you audit flublessly. That's all there is to it.

I'm not trying to give you a tough hill to climb. I'm just trying to give you the level of expectancy. It is not an unreal level of expectancy because on Flag<sup>2</sup> we have done it over and over again. We just do this as a habit.

The first thing we'll expect of you is flawless, absolutely perfect TRs\* and flawless metering. You've got to know the Auditor's Code<sup>3</sup> cold. We take it for granted you know your tools and your technology. We

take it for granted that you're good of heart and do your best.

If you expect it'll take years to learn this, change your line of thinking. It does take scores of hours of auditing before you consider that your auditing is effortless and hundreds of hours before you are to a point where nothing fazes you at all and you handle anything perfectly, flublessly.

All we want you to do now is put in lots of auditing and become absolutely letter perfect and you've got it made.

There is no other way out than as a perfect auditor. And when I say perfect, I want to qualify that: I mean *perfect*.

1. C/S: A case supervisor direction of what to audit on a preclear; Also a case supervisor who is that person in a Scientology Church who gives instructions regarding and supervises the auditing of preclears.

2. Flag® retreat: The Flag Service Org.

3. TRs: Training Regimen or routine. Often referred to as a training drill.

4. Auditor's Code: A collection of rules (do's and don'ts) that an auditor follows while auditing someone, which ensures that the preclear will get the greatest possible gain out of the processing that he is having.



## Interview with the ASHO Day Intern Supervisor



# "The Intern has got to know his tech cold and we make sure he does."

**Editor's Note:** Alan Prager is the highly-trained Intern Supervisor at ASHO Day. Here he discusses how the renowned ASHO Day Internship produces the top professional auditors on the planet.

### Auditor Ed.: What training have you had?

**Alan:** I've done *Dianetics* and Academy Level training, the Organization Executive Course, course supervisor, word clearer and cramming officer training and I am through a section of the Saint Hill Special Briefing Course.

### Auditor Ed.: What kind of supervision does the the intern at ASHO Day receive?

**Alan:** He receives razor-sharp correction and scrupulous supervision under the trained eyes of our case supervisors. These people are sharp and are expertly trained to do exactly the standard action and they correct auditors to operate in that manner. We have a heavy emphasis on basics — perfect TRs and exact metering. We use the video line liberally. All the intern auditors video and their videos frequently get critiques from Religious Technology Center. The critiquing is very exact so the fundamental errors which that auditor is making get picked up. Things that interns have had for years as auditors — little quirks or uncertainties or ways they always learned how to do it that were non-standard — get picked up.

It is a very high pressure, fast-moving scene in the ASHO Day Hubbard Guidance Center where the interns audit. The intern has got to know his tech cold and we make sure he does. The interns do a lot of drilling and daily TRs. They listen to LRH auditing demonstration tapes so they can compare their TRs to his. We show the E-Meter Reads Drill film every day so the intern can see the reads with the correct identification again and again and again so he can recognize them instinctively. This action coupled with daily drilling on his metering enables him to get his metering down cold.

We have a heavy emphasis on basics plus really picking up the points in cramming that exactly need to be corrected. The C/Ses hold the technical line. If the preclear isn't getting exactly what he needs, they find out where the auditor is erring and they order the exact correction the auditor needs and the Cramming Officer takes it from there.

### Auditor Ed.: What are the qualifications of the ASHO Day case supervisors?

**Alan:** The Senior C/S ASHO Day is one of the most highly trained C/Ses in the world. She is also the Senior C/S Western United States. She is a f7a#-trained Class VIII C/S. She has C/Sed for many, many years both at the Flag® religious retreat and at ASHO. We have a total of five C/Ses at ASHO Day, four of which are Class VIIIs and they are all excellent. The Intern will generally work under all of them at some point and his progress is closely overseen by the Senior C/S.

The ASHO Day Cramming Officer who personally carries out the intern's cramming and instruction assignments has had himself 5,000 hours of experience in the chair as an auditor. He knows backwards and forwards any kind of error an auditor could make. He is an excellent auditor himself and as well one of the most highly trained cramming officers on the planet. He is also a trained course supervisor and co-audit course supervisor. He has worked very closely with Religious Technology Center (RTC) just by virtue of the RTC critiques and crams that come into the org on the interns and the HOC auditors.

### Auditor Ed.: What is an RTC Cram?

**Alan:** The RTC Tech Inspectors receive pc folders from all over the world. Many pes have programs that are from RTC Tech Inspectors and RTC keeps an eye on the pes on such programs. RTC also receives videos from auditors from all over the world.

We have all of our interns send videos to RTC when they audit in the HGC. So basically if RTC receives a video, its technical inspector will critique it and write a cram on anything not right. The cram is gone over by our Cramming Officer with the intern in a full metered interview which includes the flying of Rudiments. The intern does the cram, gets the errors corrected and then goes ahead and makes another video. He continues this process until he receives a pass on his TRs and

metering. Ultimately the intern sends videos to the Senior C/S International Office on his confessional auditing and other skills. But the basics are TRs and metering.

The RTC correction is so accurate that I have had many interns say that what RTC pointed out is exactly what was wrong with his TRs or auditor presence or metering. Or RTC will pick up something that has not been picked up before and the cramming officer here will debug it, find the why behind the problems and have a precise cramming

cycle with the intern.

Cramming at ASHO Day is done 100% standardly on the meter. The intern will have C/S OK to receive cramming. We make full use of all the cramming tools, starting with Cramming Rudiments which guarantee the auditor is very good indicators at the end of each cramming cycle. Other cramming tools used liberally are word clearing, False Data Stripping, Crashing Misunderstood Word Finding, Product Debugs and any other correction tools needed to get the intern to a point where he is auditing flublessly for that level.

A person asks "How do you get to be a flubless auditor?" Well there is an actual technology laid out in LRH bulletins, policy letters and tapes to make a flubless auditor so we take anyone who has done his training on whatever course and we find out what is pre-

venting him from being flubless and just get those things corrected.

### Auditor Ed.: How do ASHO interns do after graduation?

**Alan:** Very, very well. Bill Penninger, as an example, is doing incredibly well building up his field practice in Chicago. He has just finished his *False Purpose Rundown*™, counselling internship. Another recent graduate of the Class VIII Case Supervisor Internship, Harrie Van Der Heijden is an extremely successful Field Staff Member. Basically the

the auditor has his cramming officer, intern supervisor, case supervisor, word clearer and all his courseroom type people to help him get trained better. And on the other side he has the Director of Processing with all the public pes who are donating to receive *Scientology* processing and get up *The Bridge* grade chart now. And all that pc's life problems — his boss, his wife, his family and his scene here and his scene there. And this auditor is going to have to confront that pc and get them handled. LRH said in writing an intern in 1972 (page 165, Tech Vol 9) "You're an auditor not a student. So don't act like a student learning to audit." That is the gist of it. The theory and the courseroom atmosphere merge on the internship.

When the intern goes into session with that public preclear and when he has done it in session after session, day after day after day, to a point where he can do it flublessly on a TV camera with his metering and TRs being recorded on video tape and have the video go up to RTC and when his pes and everybody says, "This guy can audit" — that intern KNOWS he can audit. He can go out and audit and survive very well over a long period of time. We need to make thousands of auditors with that kind of viability factor. At ASHO Day we have got the resources and the tools to train them just that way.

If anyone is hesitant about starting an internship, I would say this to them "If you are hesitant at all about embarking on this adventure we call the internship, anything in you that might be holding you back from doing it, is likely to come to the fore when you do this cycle. Any weakness or confusions you have on the tech will come out. It is going to take some confronting but if you are willing, we are right there behind you to give you whatever debugging and correction you need to get you through. Those bugs and weak points are probably the same bugs and weak points that are holding you back as a *Scientologist* in other aspects of your life. Doing the internship cycle will help you get those things ironed out." I have had so many interns who have told me they handle so much better this or that area of their life since doing the internship that had nothing to do with the internship directly.

What may be preventing a guy from doing an internship may also be preventing him from doing other things in his life that he wants to do. By coming here, by confronting it through the internship route, he can be freed up in those areas. The end result is a level of competence others marvel at, an ability to spot and handle situations as a true professional. That's the product of the Saint Hill Internship.

## All Auditors, Case Supervisors, Course Supervisors All Technical and Qualifications Division Personnel

In some areas there has been a situation of auditors and other technical staff missing withholds<sup>1</sup> on pes and failing as sec checkers<sup>2</sup> and as auditors. This has included instances of:

- (1) auditors and C/Ses not seeing the manifestations of missed withholds on pes who had them;
- (2) auditors failing at sec checking and getting busted for missing W/Hs on pcs.
- (3) auditors ceasing to deliver sec checks and, in some cases, ceasing to audit altogether.

A recent eval<sup>4</sup> has found the Why for this to be an omitted handling of the Tech-^ and Qual<sup>6</sup> staffs own O/Ws<sup>7</sup> and

1. **Missed Withhold:** A missed withhold is something people nearly found out. It's a should have known. The pc feels you should have found out about something and you didn't.
2. **Sec Checker:** Security checking. Remedying the compulsion or obsession to commit actions which have to be withheld, i.e. we are remedying unreasonable action.
3. **Withhold:** Something the preclear did that he isn't talking about.
4. **Eval:** Evaluation. The purpose of an evaluation is to isolate and handle the cause of a non-optimum situation so as to reverse and improve it toward an ideal scene.
5. **Tech:** Technical Division. The division of the org that delivers training and processing.
6. **Qualifications Division:** (Division 5 of a church) where the student is examined and where he many receive cramming or special assistance.
7. **O/Ws:** Ovens and Withholds. See definitions for "Overt" and "Withhold."
8. **Overt:** An intentionally committed harmful act committed in an effort to resolve a problem.
9. **Suppressive Person:** One that actively seeks to suppress or damage Scientology or a Scientologist by suppressive acts.
10. **Amnesty:** A general pardon for past offenses; the granting of such a pardon: a forgetting or intentional overlooking; the rendering of punishment null and void lot offenses earlier than the amnesty date, known or unknown; forgiveness of past criminal or antisocial actions.
11. **Cramming:** The cramming section teaches students what they have missed.
12. **Word Clearer:** One who is qualified in and uses the technology of word clearing, a technique for locating and handling (clearing) misunderstood words.
13. **Comm Ev:** Committee of Evidence. A fact-finding group appointed and empowered to impartially investigate and recommend upon Scientology matters of a fairly severe ethical nature.

underlying false purposes. This was the primary bug causing the situation.

This follows the *LRH*<sup>™</sup> datum:

"... Perception reduces in ratio to overts<sup>8</sup>. Accept that fact as it's true. If you run O/W on an auditor regarding the pc he is to audit, the auditor will give a perfect session to that pc. Why? He can confront because he can see."

(Ref: HCOB 20 June 71, C/S Series -47, THE SUPREME TEST OF A CVS)

In digging deeper into this scene, it was found that a great deal of vital *LRH* material on the subject of sec checking had been knocked out of use years ago by a suppressive<sup>9</sup> and had become "lost tech". This material included specific *LRH* tech and policy on auditors and other staff getting their own O/Ws cleaned up (such as HCO PL 4 Dec 63, ORG STAFF W/H CHECKS, page 228 in OEC Vol 5). With this pushed out of active use — causing auditors to accumulate O/Ws and leaving them with blind spots and lowered perception — and with other important materials on sec checking and W/H pulling obscured, a number of auditors have had troubles. And losses with pes.

These *LRH* materials on sec checking have been recovered and are currently being restored to full use.

It has always been *LRH*'s intention that auditors are able to come clean and stay clean. They are, in his words, the most valuable beings on the planet.

Therefore, I am hereby implementing an international amnesty<sup>10</sup> for all auditors, C/Ses, Supervisors and other Tech or Qual personnel.

### WHO THIS AMNESTY APPLIES TO

This amnesty specifically applies to all past or present auditors, C/Ses, Course Supervisors, Cramming Officers<sup>10</sup>, Word Clearers<sup>12</sup>, and other Tech & Qual Div personnel, whether on staff or in the field. It includes any Tech or Qual person who, prior to the date of this issue, has received a Comm Ev<sup>12</sup> or some other justice action for out tech.

But the amnesty is *not* restricted to just those tech people who have been busted; it applies equally to those who have committed O/Ws that they potentially *could* get in trouble for.

### ACCEPTING THE AMNESTY

To accept this technical amnesty you need to:

1. Disclose all overts and withholds, including any violations of standard tech and instances of non-application of the tech. These are to be written up following HCOB 2 Mar 84, O/W WRITE-UPS.

(Note: Any O/Ws committed prior to this amnesty which are later found to have been knowingly withheld in accepting this amnesty will be met with double the usual penalty.)

2. On a sheet of paper writeup what tech training you have done, where and when the training was done, and, in the case of any suspended certs, give a brief description of the stated reason for the suspension. Attach this paper to your O/W write-up and send it to Snr C/S Int via the International Justice Chief. Also send a copy of the O/W write up to your local Qual for filing in your pc folder.

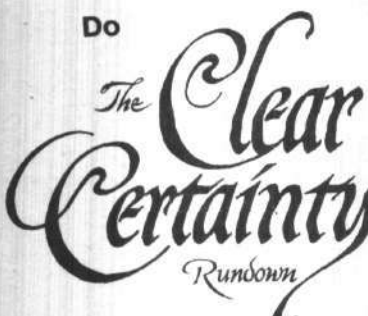

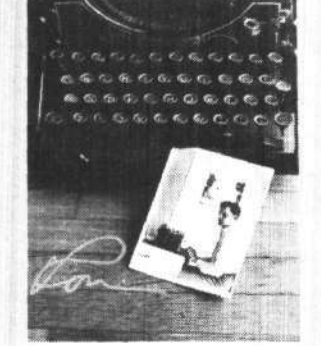

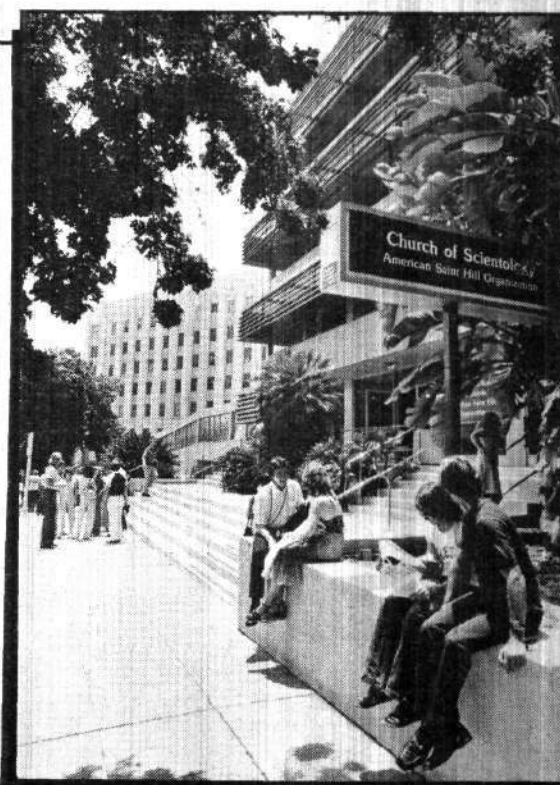
